An Overview of Association of Medical Physicists of India

The Association of Medical Physicists of India (AMPI) was established in 1976 as a non-profit public trust organization with the objectives (i) to promote the advancements of physics as applied to medicine especially radiotherapy, nuclear medicine, radiology and biological sciences (ii) to take appropriate steps to carryout, support and to encourage research and development as well as teaching with various fields associated with application of physics in medical sciences (iii) to provide the forum for persons who are engaged or interested in the field of Medical Physics and to arrange scientific meetings and discussion.(iv) to initiate measures to disseminate worldwide information (v) to promote academic status of medical physics and its educational regulations in the medical institution where Medical Physics work is carried out in India and to encourage appropriate authorities to implement the suggestions laid down by the Association (vii) to initiate action and maintain the standards in the practice of medical physics by certifying members of AMPI by conducting periodical examinations.

The AMPI is affiliated to the Indian National Science Academy (INSA) as well to the International Organization of Medical Physicists (IOMP) and its constituent member of IOMP regional chapter, the Asia-Oceania Federation of Organizations for Medical Physics (AFOMP). Currently, it has around 2500 members comprising of radiation/medical physicists, radiation oncologists, radiologists, biomedical engineers and technologists. The wide spectrum of membership reflects the multi-disciplinary nature of the medical physics profession and the association.

AMPI is periodically organizing the scientific activities in the form of annual conferences/workshop/symposia for improving professionals' standards for practicing Medical Physicists across the country since its inception 40 years ago. It is important to mention that AMPI "Medical Physics Bulletin" was started in 1976 up to 1996, and thereafter it publishes indexed scientific journal namely "Journal of Medical Physics" (JMP') in every quarterly and it has been accepted as a national leading journal and it has its reputation globally.

AMPI also established its academic wing namely College of Medical Physicists of India (CMPI) in the year 2009, to improve the academic standards and also to maintain the standard of professional practices of the Medical Physicists by conducting competency examination for accreditation and certification similar to the Medical Physics colleges of Canada, Europe, USA and Australia.

The General Body of the association is a supreme authority to control all activities and delegates its power conferred by its constitution to carry out the association affairs of professional, scientific, academic, administrative and financial aspects to achieve the objectives. AMPI is managed by the Executive Committee (EC), the Board of Trustees (BOT), editorial board of Journal (JMP) and the board of College (CMPI). ANNUAL REPORTS FOR THE YEAR 2016-2017

I. Membership

Total 59 new members have inducted during this period and their data have been uploaded on AMPI website. As on 06th October 2017 there are 2460 life members on the role of association including 59 life members enrolled during this year. The details of new members list is enclosed in Annexure I.

II. General Body

The 40th Annual General Body meeting (AGBM) which was held at Hotel Marriott Convention Centre, Hyderabad on 19th November, 2016 and the detailed minutes of 40th Annual GBM is enclosed for member's confirmation in Annexure-II.

Administration: Executive Committee

The administration of association is managed by executive committee (EC) and Board of Trustees. The administration related to professional development activities, scientific activities, academic/educational activities and financial activities of the association were carried-out and reports of the same is presented for the period of 2016-2017.

Highlights of the Executive committee meeting's important decisions/actions taken

Since the last Annual GBM held on 19th November 2016 at Hyderabad, the executive committee (EC) met one time and 278th EC meeting was held at Aditya Birla Hospital, Pune on 06th May, 2017 to transact the business of the association. The important decisions/action were taken as follows;

 $278^{\rm th}$ AMPI-EC meeting was held on $06^{\rm th}$ May 2017 at 9 AM at Aditya Birla Memorial Hospital, Pune, Maharashtra.

- 1. Dr.P.Suresh was appointed as Retuning Officer/Election Officer of AMPI election for the year 2017-2020 and also to conduct of election of office bearers.
- 2. Dr.P.G.G.Kurup was nominated as "AMPI-Ramaiah Naidu Oration Awardee" for the year 2017 and the same award will be given during AMPICON2017 at Jaipur.
- 3. The award selection committee was formed for evaluating the applications of AMPI Awards for the year 2017 and also pending application of 2016.

- 4. EC decided to provide 5 lakhs loan to AMPICON2017 organizer's with conditions that this loan amount should be returned on or before two months from the end of the conference or 31st December of that year whichever falls earlier.
- 5. It was decided that 150% of 2nd AC train ticket fair plus and Rs.1000 as a daily allowance will be given to all EC members who are attending the EC meeting. The 2 days DA will be given to those who have travelled less than 500 KM and 3 days DA will be given to those who have travelled more than 500 KM. This will be closely to the economic air fair in order to encourage more EC members for the attending the EC meetings.
- 6. Regarding AMPI website redesigning, it was decided that the existing contractor/vendor will continue to provide services and this job will be looked after by the committee having Secretary, AMPI and two more members, i.e. one each members from BOT and CMPI in the committee and committee will oversee the modification of AMPI website.
- 7. It was decided that Medical Physics staffing survey questionnaire including internship and educational course being conducted in the country should be completed soon and need to be circulated to EC members before circulation.
 - AMPI Oversees Travel Grant was Awarded to the following AMPI members for April-June 2017 Quarters
- AMPI overseas travels grant of Rs.25000/ was awarded to Ms. Sonal Varshney to participate in the International Conference on Physics in Medicine and Clinical Neuroelectrophysiology (PMCN) 2017 from 10th to 11th March, 2017 at Nabab Nawab Ali Senate Bhaban University of Dhaka, Bangladesh.
- 2. An AMPI overseas travel grant of Rs.25,000/ was awarded to Dr.S.Sathiyan to participate the International Conference on Advances in Radiation Oncology (ICARO2) to be held during 20th June 2017 to 23rd June 2017 at International Atomic Energy Agency (IAEA), Vienna International Centre in Vienna, Austria.
 - Overall Accomplishments, Action Taken and Initiatives of AMPI during the year 2015-2017 tenure.
 - After taken over the charge from the day one to till date, current EC made following the major accomplishments, Action taken and initiatives;
- 1. Implementation of scientific presentations on professional aspects of Medical Physics by EC members in EC meeting and 5 hours sitting of EC.

- 2. AMPI honorary membership (HM-001) award was conferred to Dr.Slavik Tabakov who is presently a Programme Director & Consultant Medical Physicist at King's College London (KCL), School of Medicine at the Dept.Medical Engineering and Physics, King's College Hospital London, UK and the President of International Organization for Medical Physics (IOMP).
- 3. One hundred eight (108) life members were newly enrolled during this tenure. Five members have received AMPI oversees conference travel grant.
- 4. Constitution of Subcommittees of AMPI EC was made in fulfilling AMPI goals and objectives to look after professional, academic, scientific, administrative and financial aspects of AMPI affairs.
- 5. AMPI provided financial support to the AMPICON2017 organizer for bidding and hosting AOCMP 2017 first time in India.
- 6. AMPI submitted its memorandum for amendments in Allied Health professional council bill, because the Medical Physicist was put under technical category list.
- 7. AMPI submitted its memorandum to AIIMS-Patna, AIIMS-Jodhpur and AIIMS Delhi, PGI Chandigarh, DSCI Delhi and other institutions in Bhubaneswar(IOP), Karnal, Haryana (Kalpana Chawla Medical College) and Himachal Pradesh (Govt.of Himachal) for amendments in the educational qualification for recruiting Medical Physicists and RSO at their institutions.
- 8. AMPI submitted its memorandum to Medical Council of India (MCI), National Medical Commission of NITI Aayog, Govt.of India to include Medical Physics discipline in the newly forming Medical Regulation commission as exist in MCI.
- 9. Encouraged AMPI regional/state chapters to celebrate International Day of Medical Physics (IDMP) with partial financial support and made a guideline for financial support and AMPI endorsement.
- 10. AMPI delegation (Prof.Arun Chougule, Dr.V.Subramani, Dr.Manoj Semwal, Dr.Pratikkumar and Dr.Atul Tyagi) was invited for Radiotherapy advisory group meeting in Ministry of Health and Family Welfare and made decision on nomenclature and career progression and course curriculum for Radiotherapy technologists (RTT) India.
- 11. Five member AMPI delegation (Prof.Arun Chougule, Dr.A.K.Rath, Dr.V.Subramani, Dr.E.Varadharajan and Dr.Atul Tyagi) met with the Chairman, AERB in Mumbai and deliberated Medical Physics professional matters/issues pertaining to radiation safety regulations and its code. As a

- result/outcome of the meeting, AERB sent letter to UGC for affiliation requirements for conducting Medical Physics course.
- 12. Implementation of Special General Body Meeting at Delhi based on request of AMPI members and also conducting the Annual General Body Meeting during AMPICON as per amended AMPI constitution and the same was implemented from Hyderabad.
- 13. Three members AMPI delegation (Dr.A.K.Rath, Dr.Manoj Semwal and Dr.V.Subramani) met with Union Health Secretary, MoHFW, GOI Shri.C.K.Mishra I.A.S and deliberated issues related to the anomalies in the educational qualification for recruiting Medical Physicists in 6 AIIMS and other Govt. Medical colleges/institutions and submitted the memorandum to that effect.
- 14. The issue of discrepancy in educational qualification criteria for medical teacher in Radiological physics discipline with Medical Council of India (MCI) was followed-up and recently TEQ subcommittee of MCI was approved the corrected in educational qualification as per the recommendation of AMPI and AERB in its GBM of MCI held on 29, March 2017 and matter is in the near completion stage.
- 15. The AMPI newsletter in the name of Medical Physics Gazette was started.
- 16. AROI president was invited to deliver a guest lecture in AMPI annual conference.
- 16. Updated guideline for conducting AMPICON and memorandum of understanding (MOU) between AMPICON organizer and AMPI was made.
- 17. The overseas travel grant to the AMPI member was increased from Rs.25,000 to Rs. 50,000 and updated the guideline.
- 18. AMPI quiz program was introduced with financial support during annual AMPI conference to the students.
- 19. The provision was made to conduct the national annual workshop of AMPI with financial support of 1lakh.
- 20. Approval/sanctioned the formation of Kerala chapter of AMPI establishment as one more AMPI Chapter.
- 21. Facilitated through learning resources in the AMPI website by providing Medical Physics articles and IOMP and AFOMP Newsletters.

- 22. Implementation of AMPI amended constitution w.e.f March 2016 immediately after Charity Commission, Mumbai regularization of AMPI trust
- 23. Constitution of AMPI Task Groups on (i) Staffing of Medical Physics requirements in India (ii) Medical Physicist's Roles and Responsibilities for making AMPI policy statement are work-in-progress (survey questionnaire is in completion stage).
- 25. Constitution of AMPI disciplinary and arbitrary committees were formed as per the requirement of new AMP constitution.
- 26. Constitution of legal Committee to look after AMPI legal matter in the supreme court of India.
- 27. AMPI (Dr.A.K.Rath and Dr.V.Subramani) participated in the meeting of review of radiation safety code at AERB on 09-12-2016.
- 28. AMPI participated (Dr.V.Subramani) in Indian Bureau Standard (IBS) meeting in New Delhi after gap of 3 years for providing technical inputs on radiation equipments safety standards.
- 29. AMPI introduced the provision of partial financial support for neibhouring countries Medical Physicists from Bangladesh and Nepal to attend the annual AMPI conference.
- 30. AMPI submitted its comments/suggestions on draft AERB regulation of Employment of Personnel in radiation facility in safety manual recently.

(IV). Board of Trustees

Report of Board of Trustees (BOT) Activities during year 2016-17 as follows:

During the financial year 2016-17, BOT had two meetings in Mumbai.

During deliberations on various matters, following were noted and action taken accordingly:

- 1. All investment instruments of BOT and JMP were monitored, regularized and updated.
- 2. It was noted that as per the constitution of the AMPI, Trust Fund should consist of (a) all donations received other than specific activities (b) subscription of all life members (c) Admission fee of members (d) Up to 25% of the net income after each financial year

- 3. In addition to above, it was understood that 50% of net income of annual conference should be transferred to the Trust fund. However, it is noted that no funds have been transferred to BOT.
- 4. It was also noted that Chapters of AMPI are liable to AMPI according to Clause X of the constitution. Financial liabilities are defined in Clause X, 7 and 8. It is recommended that EC of AMPI should discus and clarify the liability of all its Chapters.
- 5. BOT has judiciously allocated funds of Rs. 2 lakes to CMPI for continuation of its activities after consultation with all BOT members through emails.
- 6. It was noted that BOT fund need to be invested for its optimized gains. For this purpose, BOT has taken the help of a financial advisor. BOT proposes to invest further with the advice of financial advisor.
- 7. Further investments of BOT are under review.

V) Scientific Journal of the Association

Report of Journal of Medical Physics (JMP) activities for the year 2016-2017:

All the 4 issues of 2016 of Journal of Medical Physics (JMP) were published (both as online and print versions) well within the time limits. During 2016, a total of 139 manuscripts were received and evaluated. Out of these, 49 manuscripts were accepted, 82 were rejected and 8 were withdrawn. The published manuscripts included a Review Article, 28 Original Articles; 4 Editorials, and 6 Scientific / Technical Notes, 3 Letters to Editor, Book Reviews and some other features. For the year 2017, the three issues have already been published and the preparation for the 4th issue is under progress. During the current year (till September 30, 2017), 121 manuscripts have been received and decision on several of them has been arrived at whereas several others are under processing. As per the prevelant practice, each manuscript was reviewed by a minimum of 2 referees and the peer reviewing was kept mandatory for all manuscripts (including Editorials) whether invited or proffered.

In the past two years, the submissions of manuscripts has considerably increased [in 2015 only 98 manuscripts were received as compared to 139 in 2016 and 121 (till September) in 2017] not only from India but also from other developed and developing countries. This indicates the increasing popularity of JMP. Of course, the work of handling and refereeing the manuscripts has also increased accordingly. Also, the variety of the manuscripts covering new topics / newer research has also

gone up. Obviously, this needs to strengthen and upgrade the Editorial Board and to attract experts from different fields to undertake the refereeing for JMP so as to enhance the quality and the speed of refereeing process."

(VI) Scientific Conference/Workshop/Symposia of the Association

Report of AMPICON2016

37th Annual Conference of AMPI (AMPICON2016) at Hotel Marriott Conventional Centre, Hyderabad from 18-20th November, 2016



37th Annual Conference of Association of Medical Physicists of India, AMPICON-2016, is scheduled during 18-20 November, 2016 at Hotel Marriott & Convention Centre, Hyderabad. This conference is being organized by the KIMS Cancer Center, Krishna Institute of Medical Sciences, Secunderabad in association with the AMPI-TS & AP Chapter.

The **theme** of the conference was "**Innovative Radiological Applications for Improved Cancer Care**". More than five hundred (500) delegates including Medical Physicists, Radiation Oncologists, Radiologists, Radiotherapy Technologists and Biomedical Engineers from different parts of the country and abroad and students of these disciplines participated in the conference.

The three day conference featured scientific sessions and symposiums in two parallel tracks discussing the latest scientific research and developments in Medical Imaging, Radiation Therapy, Nuclear Medicine, Health Physics, Radiology, Quantitative imaging, Particle therapy etc. Many international clinical Medical Physicists, scientists and other well-known national personalities have presented papers in the conference. Scientists from Atomic Energy Regulatory Board, Bhabha Atomic Research Centre and others from leading Cancer Institute's like AIIMS, TMH etc participated in the conference.

AMPI Awards 2016 during AMPICON2016

(i) Dr. Ramaiah Naidu Memorial oration of 2016 Awardee

Dr.M.M.Rehani received AMPI Dr. Ramaiah Naidu Memorial oration for the year 2016 during AMPICON-2016 and he is presently Director of Global Outreach for Radiation Protection, Massachusetts General Hospital (MGH), Harvard Medical School, Boston & also Adjunct Professor of Radiology & Medical Physics, Duke University, USA. He is holding professional leadership position as Vice President, International Organization for Medical Physics (IOMP) & Chairman, Working Group for IAEA conferences and Secretary, International Commission on Radiation Protection (ICRP) Protection in Medicine Committee and *Ex*-Radiation Safety Specialist, IAEA, Vienna and Ex-Professor of Medical Physics at All India Institute of Medical Sciences, New Delhi India.



AMPI also encouraging the younger upcoming Medical Physicists in the field by instituting the best oral paper and best poster award. AMPI Best (Oral) Paper Award was received by Mr. K Balaji for paper entitled on "A Study to find optimal Weightage in Hybrid VMAT Technique for the Treatment of Post Mastectomy Breast Patients" and AMPI Best (Poster) Paper Award was received by Mr.Nitin R Kakade for the paper entitled on Dosimetric Audit in IMRT/VMAT using

indigenously developed Anthropomorphic Head and Neck Phantom" and AMPI Meritorious Medical Physics Award was received by Mr. Devi Prasad Pandey for the year 2016 during AMPICON2016.

A quiz programme was also conducted for the students to create awareness on recent trends in Medical Physics and the winner received the AMPI cash award. An e-poster session was also a part of the conference.

Prof. Arun Chougule, President, AMPI welcomed the conference delegates and audience on behalf of AMPI. Dr.V.Subramani, Secretary, AMPI reported AMPI progress and annual report to the audience/delegates and Organizing Secretary of AMPICON2016 gave the vote of thanks.

On second day, having important scientific deliberations, in the evening, the annual General Body meeting of AMPI was held on 19th November, 2016. The meeting was attended by around 150 AMPI members. On third day, AMPI awards ceremony was held and the conference ended on 20nd Nov, 2016 with the announcement of holding the AMPICON 2017 at Jaipur.

VII. College of Medical Physics of India (CMPI)

College of Medical Physics of India activities for 2016-17 as follows:

CMPI 2016:

There was a positive response showing gradual increasing over the years in the number of candidates showing interest in the CMPI certification process. Seventeen two (17) applicants paid the fee and intended to appear for the written examination, however only 7 candidates appeared on the oral examination and were declared successful for the year 2016.

In endeavor to promote academic activities, CMPI could conduct only one "CMPI teaching session – Image guided radiation therapy" during the AMPICON-NC 2016 held on February 2016 at BHU, Varanasi. The session include three lectures 1) Overview of Image Guided Radiotherapy by Dr KJ Maria Das, 2) Clinical practice of IGRT with correction strategy by Dr. T. Ganesh and 3) Quality assurance of Image guided Radiotherapy by Mr. Ritu Raj. These lectures were informative, involving discussion and was well received and appreciated by the audience.

CMPI 2017:

Very good response showing rapid increase in the number of candidates showing interest in the CMPI certification process.

Thirty eight (38) candidates paid the fee and intended to appear for the written examination for the year 2017. Twenty six candidates appeared for the written examination, out of which 20 candidates qualified and declared eligible for

appearing the oral examination, Eighteen candidates had paid the fees for appearing the oral examination on 3rd Nov 2017 at Jaipur.

CMPI Endorsed Teaching Course was conducted by AMPI - Eastern Chapter and Apollo Gleneagles Hospital Kolkata held on April 15-16, 2017 which was a very successfully meeting with about 45 participants covering the various aspects of advancement in Medical Physics. Dr. T. Ganesh and Dr. Kabasi were the coordinator for this teaching course.

In endeavor to increase the candidates for CMPI certification process, CMPI conducted the "1st CMPI Refresher course" for potential candidates who are interested in appearing for the certification held on 23-24th June 2017 at RPAD, BARC, Mumbai co-ordinated by Dr. SD Sharma and Dr. Jamema. These lectures were interactive, informative, involving discussion and was well received and appreciated by the about 40 participants including candidates who may appear in the subsequent year.

VIII. Report on AMPI regional/state chapters of activities during 2016-2017

A). Eastern Chapter

- 1. Last AGM of the chapter was held on 7th January 2017 at 3 p.m. in the seminar room (ground floor) of Chittaranjan National Cancer Institute, Kolkata. New office bearers of the chapter was elected after 3 years.
- 2. The 1st Executive meeting of the new office bearers was held on 10.02.17 for the discussion on the proposed CMPI programme. EC decided to organize a CMPI teaching programme on "QA, Advance Dosimetry, Treatment Planning and Verification for the External Beam Therapy" on 14th and 15th April 2017.
- 3. There were two pre-CMPI local teaching programs for the local participants held on 11th March and 18th March in Ruby General Hospitals and Apollo Gleneagles Hospitals respectively. Mr. Srimanta Pramanik and Mr. Arko Choudhury gave lectures and hands on training on QA and performance test of LINAC according to AERB protocol on 11th March. Mr.Nagendran and Ms. Kaliselvi of Apollo G Hospital Kolkata gave hands on training on IMRT QA on 18th March 2017. Almost 20 participants attended those teaching programme.
- 4. On 14th and 15th April, 2017, the main CMPI teaching programme was held in the Main Building Auditorium, Apollo Gleneagles Hospitals. Dr. M. Ravi Kumar, Dr. Alok Kumar, Mr. V.K. Sathiyanarayan, Mr Raghavendra Holla, Mr. S. N. Singh, Dr T. Ganesh and Mr. V. Poopthi gave elaborate lectures on the planned topics. Participants from all over India and from Bangladesh attended the course. Registration fee of the programme was Rs. 500/- only.

At the end of the course there was a multiple choice examination was held and most of the participants did well.

5. Minutes of the Special Annual General Body Meeting 2015 of Association of Medical Physicists of India

The Special Annual General Body Meeting of Association of Medical Physicists of India was held on 21st November, 2015 at AMPICON2015 venue, Kovalam, Thiruvananthapuram, Kerala. The AMPI Officers i.e. President, Vice-President, Secretary and Treasurer were on the Dias. The meeting attended by 107 AMPI members. The President, AMPI opened the meeting by welcoming all members. The President, AMPI asked the Secretary AMPI to proceed the meeting with listed agenda. The following decisions were taken based on the discussion with all members in the house.

Agenda Item 1: To present the motion on MCI and AERB Related Issues

MCI Issue: Revision on MCI minimum qualification criteria for Radiological/Medical Physics Teachers

The Secretary, AMPI informed to the house that revision/correction in the essential qualification for teachers in the discipline of Radiological Physics/Medical Physics is still pending despite of previous AMPI office repeated requests to MCI. The newly elected AMPI office has recently submitted a memorandum to MCI on this matter and requesting MCI to make necessary corrections in the essential qualification for teachers in the discipline of Radiological Physics/Medical Physics as per the Gazette Notification gazette vide part-III, Section-4 dated 23 March, 2010. On this issue Dr.Ajaj Srivastava asked secretary to updates the house. The Secretary, AMPI requested the President, AMPI to respond to Dr.Ajaj Srivastava, since the President, AMPI was involving from the beginning on this matter.

The President, AMPI replied that the essential educational qualification for Radiological Physics/Medical Physics teachers, as per the gazette notifications are not reflecting in Minimum Qualification for Teachers in Medical Institutions Regulations, 1998 (Amended up to May 2015) which are available on MCI website. The president, AMPI informed to the house that MCI has accepted basic qualification as per the AERB recent safety code i.e. M.Sc. Physics + DRP or M.Sc. Medical Physics along with one year internship, instead of M.Sc. (Physics), Biophysics and M.Sc. chemistry etc. He has also informed to the house that the PhD is not required as an essential qualification for the Assistant professor in Radiological Physics/Medical Physics. The same was appreciated by the house.

It was also brought to the notice by members from the house that regarding MCI requirements of staffing for starting radiotherapy department in medical institute/college, it is mentioned that requirement of a "Physicist". However the house was discussed the same and unanimously agreed that it should be mentioned as "Assistant Professor of Radiological Physics/Medical Physics" rather than a physicist so that he/she will be involved in teaching and training as per the MD Radiotherapy curriculum. Further, the house discussed and agreed that MD Radio-diagnosis course also requires at least one teaching faculty post of Assistant Professor of Radiological Physics/Medical Physics to take care of teaching and training.

AERB IssuesNo.1: Separate Department & Head of Medical Physics in Medical Institution in India

The Secretary, AMPI informed to the house that executive members have brought to notice of the executive committee of AMPI regarding staffing in Radiotherapy in the AERB safety code. It is mentioned as one Chief Radiation Oncologist and one Chief Radiation Therapy Technologist along with other requirements based on number of patients. However, for Medical Physics cadre, the chief position was not mentioned in parallel to others. The same matter was discussed in the EC and decided to take up the matter to the Special General Body approval for making separate department



of medical physics and also head of medical physics as the chief of the department. The house also discussed the need for separate department of medical physics in order to carry out independent responsibilities such as radiological safety and quality assurance programme along with other patient-related responsibilities to ensure the safety and quality of radiation treatment of cancer patients. It was agreed by the house and further decided that AMPI office should send a memorandum requesting to AERB for making an amendment in the safety code for separate department of Medical Physics and Head of Medical Physics as the chief of Medical Physics cadre.

AERB Issue No.2: Amendment by removing the Dosimetrist staffing in the recent AERB code

The Secretary, AMPI informed to the house that executive members have brought to notice of the executive committee of AMPI about the need of amendment by removing the post of Dosimetrist in the AERB safety code. The executive committee of AMPI discussed about the need of Dosimetrist post in detail and decided by majority of voting that at present the post of Dosimetrist is not needed or required. Because at present there is no programme in our country which is conducting such course of Medical Dosimetry, practically no manpower is available for recruiting the same. Therefore it was decided to take up the matter to the Special General Body approval. All members present in the house have agreed for the same and the decision was taken with majority voting in support of the agenda. Further, it was decided that AMPI office should send a memorandum requesting to AERB to make amendment by removing the Dosimetrist staffing in the recent AERB code.

AERB Issue No.3: Inclusion of Radiation Safety syllabus in the MD (Radiotherapy, Radiodiagnosis and Nuclear Medicine) Programmes in Medical Institution

The Secretary, AMPI informed to the house that EC members have brought to notice of the executive committee of AMPI about the need for the inclusion of Radiation Safety syllabus in the MD (Radiotherapy, Radiodiagnosis and Nuclear Medicine) Programmes. Dr.S.D. Sharma has informed that it may have negative impact as well because many radiation oncologists are willing to become RSO. Prof. Arun Chougule replied that RSO responsibilities are basically duties of Medical Physics related work such as to carry out the quality assurance and quality control and hence becoming RSO by oncologists may not be practically possible. All members present in the house have agreed for the same and it was decided that AMPI office will write to AERB in the matter.

Proposed by; Suresh Pangam seconded by: Dr.Raghukumar

AERB Issue No.4: Amendments in e-LORA system i.e. mandatory provision for filling Make and Model of the Equipment during layout plan submission time.

The Secretary, AMPI informed to the house that EC members have brought to notice about requirements of amendments in e-LORA system regarding mandatory provision for filling make and model of the equipment during layout plan submission time and hence it has decided to take up this matter to the special General Body approval. The same matter was discussed in the house that the correct make and model of the equipment is not possible to know before finalizing tender therefore it was felt that only specific energy needs to be filled instead of make and model of the equipment. The house was unanimously agreed for the same decision and further decided that AMPI office should send a memorandum requesting to AERB for amendments in the e-LORA system to this effect.

Agenda Item: 2: To discuss and decide about the re-organization of the AMPI Chapters

The Secretary, AMPI informed to the house that some of the members have brought to the notice of AMPI office regarding the need for re-organization of the AMPI chapters. Dr.Madhavanath has informed to the house that there is no uniform number of states included in the regional chapters of AMPI and there is a need for re-organizing AMPI chapters. He has also informed to the house that



AMPI chapters are not necessary to conduct annual conference which usually falls within 2-3 months' time after the national annual conference and hence it may not be possible to have quality research papers in the subsequent chapter annual conferences. He also suggested that chapters can have workshops, CME and symposia instead of annual conferences. Most of the members in the house were agreed for the same suggestions, however it needed more discussion with chapters. Proposed by; Dr.Madhavanath seconded by: Dr.S.D.Sharma.

However, regarding the re-organization of AMPI chapters the most of the members present in the house were of the opinion that there is no such need to reorganize the AMPI chapters & its function. It was decided that all AMPI chapters will functional as per existing AMPI constitution. Proposed by Dr.Rajesh Khinikar & Seconded by Dr.R.Ravichandran

Agenda Item3: To examine and approve the recommendation of Executive Committee Seeking approval for EC recommendation #1: To confer the honorary membership

The Secretary, AMPI informed to the house that executive committee of AMPI decided to confer honorary membership of AMPI to Dr.Slavik Tabakov, who is presently a Programme Director & Consultant Medical Physicist at King's College London (KCL), School of Medicine at the Dept. Medical Engineering and Physics, King's College Hospital London, UK and also present President of International Organization for Medical Physics (IOMP). After detailed deliberations on this matter, the house approved the proposal of honorary membership to Dr.Slavik Tabakov by majority voting. However the second proposal of conferring honorary membership to Dr. Tea-Suk Suh who is a Professor of Biomedical Engineering, in the Catholic University Medical College & Director of Research Institute of Bio medical Engineering, Seoul, Korea, is deferred. It was also decided that the Honorary Award Committee should be constituted to confer the honorary membership of the association.

Seeking approval for EC recommendation #2: Constitution of AMPI-EC-Subcommittees

The Secretary, AMPI informed to the house that executive committee of AMPI decided to constitute subcommittees under AMPI-EC having members of outside executive committee and hence it is decided to take up the same matter to the special General Body for the approval. The Secretary, AMPI has proposed subcommittees under six heads such as Education and Training committee, Professional Development Committee, Science Committee, Administrative Committee, Publication Committee and Finance Committee through power point presentation to the members present in the house. All members present in the house advised to the AMPI office that the detailed roles and responsibilities and purpose of subcommittees' should put in the AMPI website for referral of AMPI members before approving the same.

<u>Seeking approval for EC recommendation #3: instituting P.S.NegiMedal for Best Research Paper Award for Medical Physicists In India</u>

• The Secretary, AMPI informed to the house that the proposal from Prof.P.S.Negi for instituting medal for best research paper award for best papers published in international peer reviewed journal like PMB, Medical Physics, JACMP, IJROBP, Green Journal and Medical Dosimetery for practising Medical Physicists in India. This medal should be awarded (cash award of Rs, 10,000/) out of the yearly interest of the fixed deposit of rupees two lakhs which will be donated to AMPI by Prof.P.S.Negi. The same proposal was approved in the AMPI-EC and hence decided to take up the matter to the special general body meeting. During the discussion on the agenda some of the members felt that the clarification should be sought from the proposer whether it is applicable to Medical Physicists those who are working in hospitals only or all members of the AMPI. Therefore, it is decided that the same approval from the house of SGBM is subject to the clarification from the proposer. Based on the clarification from the proposer, AMPI office will take the matter again to the General Body through group emails to all AMPI members via our Website. AMPI office will intimate to the proposer about the final outcome of the pending approval accordingly.

Amendments based on GBM2016;

The proposal from the Prof P.S Negi award for medical physicist was discussed and the house suggested to close this matter as no further communication was received from him in the query raised by AMPI office. Proposed by Shri M.P.S Mann and seconded by Dr Sudhir Kumar.

Agenda Item4: To Update the Progress of AMPICON2016 & 40 Years of AMPI celebration

The Secretary, AMPI invited the organizing Committee of AMPICON2016 to update the progress of the AMPICON2016 and Dr.Krishnamurthy Chairman, organizing Committee have made power point presentation about the AMPICON2016 arrangements and he informed to the house that detailed committees will be formed in consultation with AMPI office soon and organizers of AMPICON2016 agreed to follow all the norms of AMPI in conducting the conference. It has also unanimously decided by the house that the forthcoming AMPICON2016 will be of 40th Year of AMPI and celebration to be arranged accordingly and all announcement of AMPICON2016 should emphasis the 40th Year of AMPI.

Agenda Item 5: Any other important matters with permission of the chair

- 1. Dr.Vishnu has informed to the house that the presently the Medical Physicists designation in all Kerala Medical Colleges are as "Physicist cum Assistant professor" and suggested to take this matter through AMPI to make uniform designation throughout the country.
- 2. Dr.P.G.G.Kurup has suggested that there is need of minimum two Medical Physicists for a single machine because of heavy workloads on RSO and the house was unanimously agreed for the same.
- 3. Dr.P.Kaliappan has suggested to the house that there should be uniform educational qualification and syllabus throughout the country. He also asked for clarification that in a situation where a single Medical Physicist or Faculty is appointed for all three disciplines such as Radiotherapy, Radiodiagnosis and Nuclear Medicine how to spend man-hours in each department. The President replied that this is very important concern and need to take this matter to the hospital/institute management for recruiting appropriate manpower as per the practice being carried out by the institute. Upon his further clarification regarding levels of RSO appointed in Radiotherapy, Radiodiagnosis and Nuclear Medicine departments, Dr.S.D.Sharma clarified that RSO level I and RSO level II will be adequate for Radiodiagnosis and Nuclear Medicine without cyclotron facility and whereas RSO level III is required for Radiotherapy department.
- 4. Dr.S.P.Agagarwal has suggested that there should be a minimum syllabus of Radiation Safety for CMPI accreditation examination and further he suggested that there should be a common syllabus of Radiation safety for both M.Sc+DRP and M.Sc Medical Physics courses to have a homogeneous pattern and will be helpful for students appearing in the RSO examination latter.
- 5. Dr.B.S.Rao has suggested that there should be expert for teaching Radiobiology to radiation oncology and Medical Physics courses in order to give importance of radiobiology syllabus as required in the educational curriculum. He also suggested that there should be a dedicated radiobiology workshop/teaching course periodically for all Medical Physicists in the country.
- 6. Mr. Rituraaj Upretti has asked about the status of one man one post for the executive members of the AMPI since it was already decided by the previous EC meeting. It has been discussed in detail in the house and decided that any individual member on their own offering resignation from the more than one post is welcome measures. However, most of the member's opinion from the house that this needs to be discussed further and to make amendments in the AMPI constitution to this effect so that implementation becomes easy.



At the end of the meeting Secretary thanked all the members and the meeting ended with thanks to the chair.

Minutes of the Special Annual General Body Meeting 2016 of Association of Medical Physicists of India

The Special General Body Meeting of Association of Medical Physicists of India (AMPI) on demand of AMPI members was scheduled at 2.PM on 09th July, 2016 at Library Hall, UCMS & GTB Hospital. The AMPI Officers i.e. President, Vice-President, Secretary were on the Dias. Initially as there was no quorum, the meeting was adjourned for 15 minutes and the actual meeting started at 2.15 PM. Total of 42 AMPI members attended the meeting. The President, AMPI opened the meeting by welcoming all members. The President, AMPI asked the Secretary AMPI to proceed the meeting with listed agenda "

Agenda Item : To discuss and decide the action plan on the educational qualification and nomenclature for recruiting Medical Physicists/Faculty in Medical Institutions

The following decisions were taken based on the discussion with all members in the house.

The Secretary, AMPI informed to the house that based on members request this SGBM meeting is being organized to discuss and take action plan on anomalies in the educational qualification for post of medical physicists/faculty as advertised in govt. institutions. The Secretary, AMPI showed the power point presentation about issues related to Medical physics profession and he informed to the house that AMPI has represented its memorandum to all concerned institutions as below mentioned for the necessary action by making corrigendum in their respective advertisements;

- (i) PGIMER, Chandigarh on qualification/nomenclature
- (ii) AIIMS Patna on qualification/nomenclature
- (iii) AIIMS Delhi on qualifications for faculty position
- (iv) Health Minister on six AIIMS regarding creating faculty position for medical physics & noninclusion of medical physicist in the procurement of radiation therapy equipment
- (v) AIIMS, Jodhpur on qualification/nomenclature
- (vi) IOP, Bhubaneswar on Pay scale & Group-B
- (vii) DSCI, Delhi qualification/nomenclature for nuclear medicine.

The Secretary, AMPI further informed to the house that AMPI had sent its representation to not only to the above mentioned issues, but also issues related Medical Physics profession including the Health Ministry issue of Medical Physicists under Allied Health Professional, MCI for qualification amendments in Faculty position and AERB, Mumbai for removing Dosimetrist & others issues and requested all members to provide further suggestion/action plan on this matter.

With respect to Health Ministry issue of Medical Physicists under Allied Health Professional, Dr. A.K. Rath & Dr. Atul Tyagi stated that before AMPI representation received by Ministry, the Medical Physicist was removed from the list of Allied Health Professional in the health ministry document. Mr.



Rajendra Kumar has suggested Medical Physicist should not be put in AHS, if required, even AMPI may have to move to the court on this matter. Secretary, AMPI replied to Mr. Rajendra Kumar that this matter was solved already and hence no need at this stage to go court.

Mr. Vinod Pandey asked about the status of MCI issues of qualification for faculty position. The Secretary requested to President, AMPI to address the same as he is involved from the beginning. The President, AMPI informed to the house that this issue is there from the year 1998, however in the year 2015 January AMPI delegation met the President, MCI and subsequently on 15th November, 2015 the new AMPI office sent representation to MCI. There is a possibility to make amendments in the qualification and separate medical physics department may not be accepted by MCI as per his follow-up information from the concerned authorities. Dr.A.K.Srivastava has asked about AMPI representation to MCI and Secretary, AMPI showed to the house about the AMPI representation regarding qualification proposed for the faculty position. The members present in the house unanimously suggested that once in a month follow-up may be required on MCI matter.

With regard to AERB issues related to removal of dosimetrist post in the AERB safety code, the secretary, AMPI informed to the house that AERB has sent letter to AMPI in response to AMPI letter dated 13-02-2016 based on Kovalam Special General Body decision on removal of dosimetrist post. Further Secretary, AMPI informed to the house that recently AMPI delegation met with Chairman and officials of AERB on 13-06-2016 at AERB Mumbai and addressed all core issues related to AERB. In response to the AMPI delegation meeting, the Chairman AERB has written letter to the Chairman, UGC for taking necessary action to ensure adequate faculty and infrastructure for running Medical Physics course by making stringent affiliation process to the Universities and secretary, AMPI showed the letter written by Chairman AERB to the Chairman, UGC to the members present in the house. The members present in the house unanimously suggested that regular follow-up may be required on the matter.

Mr. Ansari from Max hospital, Batinda has raised the question about the qualification/criteria for AMPI life membership and involvement of Medical Physicists in conducting M.Sc RTT course. After the detailed discussion on this matter, it was unanimously decided that issues of voting rights need to be amended in AMPI constitution adapting due procedure and also decided that Medical Physicists teachers should not encourage M.Sc RTT and involve as part time faculty for Medical Physicists courses.

With regard to six AIIMS matter, it was discussed and decided that AMPI should sent the representation to change the qualification for the post of Medical Physicists uniformly in all six AIIMS and also AMPI delegation need to meet the Health Minister/Ministry officials within one month time to address all matters of Medical Physics profession personally.

Regarding AIIMS, New Delhi matter related to the qualification for faculty position, it is decided that in case AIIMS is conducting interview without necessary correction in the qualification, AMPI should



move to court for necessary action on the matter. It was also decided in the house that AMPI office need to have regular follow-up on other remaining institutions and take necessary action accordingly.

At the end of the meeting Secretary thanked all the members, the authorities of GTB/UCMS and the meeting ended with thanks to the chair.




