

An Overview of Association of Medical Physicists of India

The Association of Medical Physicists of India (AMPI) was established in 1976 as a non-profit public trust organization with the objectives (i) to promote the advancements of physics as applied to medicine especially radiotherapy, nuclear medicine, radiology and biological sciences (ii) to take appropriate steps to carryout, support and to encourage research and development as well as teaching with various fields associated with application of physics in medical sciences (iii) to provide the forum for persons who are engaged or interested in the field of Medical Physics and to arrange scientific meetings and discussion.(iv) to initiate measures to disseminate worldwide information (v) to promote academic status of medical physics and its educational regulations in the medical institution where Medical Physics work is carried out in India and to encourage appropriate authorities to implement the suggestions laid down by the Association (vii) to initiate action and maintain the standards in the practice of medical physics by certifying members of AMPI by conducting periodical examinations.

The AMPI is affiliated to the Indian National Science Academy (INSA) as well to the International Organization of Medical Physicists (IOMP) and its constituent member of IOMP regional chapter, the Asia-Oceania Federation of Organizations for Medical Physics (AFOMP). The members' comprising of radiation/medical physicists, radiation oncologists, radiologists, biomedical engineers and technologists. The wide spectrum of membership reflects the multi-disciplinary nature of the medical physics profession and the association.

AMPI is periodically organizing the scientific activities in the form of annual conferences/workshop/symposia for improving professionals' standards for practicing Medical Physicists across the country since its inception 45 years ago. It is important to mention that AMPI "Medical Physics Bulletin" was started in 1976 up to 1996, and thereafter it publishes indexed scientific journal namely "Journal of Medical Physics" (JMP') in every quarterly and it has been accepted as a national leading journal and it has its reputation globally.

AMPI also established its academic wing namely College of Medical Physicists of India (CMPI) in the year 2009, to improve the academic standards and also to maintain the standard of professional practices of the Medical Physicists by conducting competency examination for accreditation and certification similar to the Medical Physics colleges of Canada, Europe, USA and Australia.

The General Body of the association is a supreme authority to control all activities and delegates its power conferred by its constitution to carry out the association affairs of professional, scientific, academic, administrative and financial aspects to achieve the objectives. AMPI is managed by the Executive Committee (EC), the Board of Trustees (BOT), editorial board of Journal (JMP) and the board of College (CMPI). ANNUAL REPORTS FOR THE YEAR 2021

I. Membership

Total 44 new members have enrolled during this period and their data have been uploaded on AMPI website. As on 07th December 2021 there are 2748 life members on the role of association including 44 life members enrolled during this year. The details of new members list is enclosed in Annexure I.

II. General Body

The 44th Annual General Body meeting (AGBM) which was held from BARC Mumbai through hybrid mode on 20th March, 2020 and the detailed minutes of 44th Annual GBM is enclosed for member's confirmation annexure-II.

III. Executive Committee Administration:

The administration of association is managed by executive committee (EC) and Board of Trustees. The administration related to professional development activities, scientific activities, academic/educational activities and financial activities of the association were carried out and reports of the same is presented for the period of 2021.

Highlights of the Executive committee meeting's important decisions/actions taken

Since the last Annual GBM held on 20th March 2020 at Mumbai, the executive committee (EC) met three times (296th, 297th and 298th EC meetings) through online to transact the business of the association. The important decisions/action were taken as follows;

296th AMPI-EC meeting was held on 24th April 2021 at 4 PM through online

- 1. **AMPI Letter on National Commission for Allied Health Profession (NCAHP):** AMPI Representation on NCAHP Bill 2020/Act 2021 was discussed and decided to send letter to the concerned authorities for making Role and profile of Radiological/Medical Physics/ Medical Physicist as amendments to the NCAHP Bill 2020/Act 2021.
- 2. **AMPI-Ramaiah Naidu Oration Awardee" for the year 2021**Dr.M.S.S.Murthy former Head of RPAD, BARC was nominated as "AMPI-Ramaiah Naidu Oration Awardee" for the year 2021 and the same award will be given during AMPICON2021 at Bangalore.
- 3. **AMPI Web Editor**: Dr.Shobha Jayaprakash, EC members was nominated as AMPI Web Editor and she will look after AMPI website related activities.

297th AMPI-EC meeting was held on 22th May 2021 at 4 PM through online.

1. AMPI representation on NCAHP Act:

Amendment by renaming the category Sr.No 8 in the schedule of NCAHP Act, from "Medical Radiology, Imaging and Therapeutic Technology Professional" to as "Radiological/Medical Physics and Technology Professionals", and add the separate work profile of the medical physicist. (ii) Amendment on the work profiles of the technologists and dosimetrist listed in this category. (B) Permanent long-term solution: Amendment by making provision for either separate category/council for "Radiological/Medical Physics" profession or clubbed with all scientists together, may be named as "Clinical Scientist" and they may be placed under "Life Sciences and Physical Sciences in Medicine" profession category/council.

2. **Updating AMPI Website**:

It was decided that Dr.Shobha Jayaprakash, Web Editor of AMPI will take initiative and plan for updating AMPI website. Dr.Henry Finlay, EC member also a member and he will coordinate with Web editor for updating the AMPI website.

3. Committee for Update/Amendments to the AMPI Constitution

The committee was formed to review and update the AMPI constitution and it was decided that Dr Manoj Semwal and Dr Shobha Jayaprakash EC members take necessary steps for bring required amendments to the AMPI constitution.

4. Committees for AMPI Policy Statement Development

"Roles and Responsibilities of Medical Physicists in India" A committee of 3 EC members with Dr.V.Subramani as coordinator and Dr Manoj Semwal, Dr.Ghanashyam Sahani as members is formed. (ii) "Staffing and career progression recommendations for Medical Physicists in India" A committee of 3 EC members with Dr Vijayaprabhu as coordinator and Dr.Sridhar Sahoo, Mr. Karthikeyan as members is formed.

5. IOMP International Conference of Medical Physics (ICMP) 2023 Award to AMPI:

IOMP has elected AMPI to organize the ICMP2023 at BARC, Mumbai India and Dr.S.D.Sharma will organize the ICMP2023. This is the first time IOMP-ICMP is to be held in India.

298th AMPI-EC meeting was held on 28th August 2021 at 4 PM through online

1. Health Ministry letter on NCAHP Act 2021 to AMPI and further action:

As AMPI received letter from Health Ministry and it was not satisfied, it was decided that a fresh communication addressed to the Chairman, NCAHP to be sent to demand the same as we sent earlier and also to send New Union Health Minister once again to represent our case.

2. An update on Revision of AMPI Constitution

It was decided that as there was no feedback received from the members regarding

amendments to the AMPI constitution, the same may be circulated to the members and EC once again and will take up for approval in the forthcoming General body meeting.

3. An Update on AMPI Website Development

Dr.Shobha Jayaprakash, EC member and Web Editor of AMPI Website informed to the EC that the website update work is in progress and will inform in the next EC meeting.

4. An Update on Task Group on Roles and Responsibilities of Medical Physicists in India.

Dr.V.Subramani In-charge for the task group gave the power point presentation to the EC about the roles and responsibilities of Medical Physicists in Radiation Oncology Physics and sought the opinion and following suggestions were made by EC:

- 1. The title of professional will be Medical Physicist.
- 2. The subspecialties of Medical Physics can be classified under two categories such as (i) Radiation Oncology Physics (ii) Medical Imaging Physics .i.e. combining all imaging physics of Diagnostics Radiology Physics, Nuclear Medicine Physics and also MRI and Ultrasound Physics.
- 3. The responsibilities of Medical Physicists will be from all the areas of their activities such as (i) Clinical Practice (ii) Education and Training (iii) Research and Development (iv) Safety and Quality Management (v). Professional Development
- 5. MBBS education also needs to include in the roles of Medical Physicists in the education.

5. An Update on AMPI-Task Group on Staffing and Career Progression for Medical Physicists in India.

Dr. Vijayaprabhu In-charge for the task group informed to EC that the said task group work is in progress and will be ready in the next EC meeting.

6. AMPI Representation on Medical Physics course recognition, NET and teacher requirements to UGC.

The matter was discussed in details and it was decided that AMPI office should communicate to UGC for the appointment for the AMPI delegation.

7. IDMP2021 Celebration and Finance support for AMPI Chapters

It has been decided that AMPI provide Rs.20,000/the financial support to all AMPI regional and state chapters to organize the scientific program commemorating Madam Curie Birthday as International Day of Medical Physics (IDMP) on 07November, 2021

Further Action Taken and Initiatives during the 2021

1. On 11th May, 2021, AMPI sent letter to the Director, NISER, Bhubaneswar regarding Anomaly in the Eligibility Qualification of Scientific Officer 'C' (Medical Physics) of Adv. No. FA-Rct./NA/02-2021 dated 5thMay 2021.

- **2.** On 30th May, 2021, AMPI sent letter to the Director, IGIMS, Patna regarding Anomaly in the Eligibility Qualification for the post of Radiation Safety Officer of Adv. No. 02/Non-Faculty post /Estt/IGIMS/2021 -Rct./NA/02-2021.
- **3.** On 21st June 2021, AMPI sent letter to the request the Principal Secretary to the Chief Minister, Govt of Assam & Director, Assam Cancer Care Foundation for corrective action on anomaly regarding "Radiation Safety Officer and Medical Physicist" under technician/technologists staff category in the recent advertisement for hiring the staffs for ACCF, Assam.
- **4.** AMPI has participated on the ESTRO Radiation Oncology Medical Physics syllabus.
- **5.** AMPI has provided good standing certificates and Professional conduct to the AMPI members who have got employment in foreign countries such as HCPC, UK and Gulf countries.
- **6.** AMPI and ESTRO Physics Committee organized online meeting for organizing Joint ESTRO-AMPI Symposium on Advanced Dosimetry during AMPICON2021 conference on 09th January, 2021.
- **7.** On 20th October, 2021, AMPI sent representation to the Chairman, National Medical Commission, erstwhile MCI, regarding anomalies in the draft Teachers eligibility qualifications regulations 2021.
- **8.** On 20th November, 2021, AMPI sent representation to the President, Postgraduate Medical Education Board (PGMEB) of National Medical Commission, erstwhile MCI, regarding anomalies in the draft Teachers eligibility qualifications regulations 2021.
- **9.** On 02nd December, 2021, AMPI 4 members delegation (Dr.S.D.Sharma, President, AMPI, Dr.V.Subramani, Secretary, AMPI, Dr.A.K.Rath, EC member and Dr.Pratik Kumar EC member) meeting was held with President, PGMEB, NMC and deliberated on issue of anomalies in the draft Teachers eligibility qualifications regulations 2021.
- **10.** On 06th December, 2021, AMPI sent representation to the Chairman UGC, New Delhi for seeking appointment for meeting to issues related to PG Medical Physics course in India.

(IV) Board of Trustee (BOT)

Report of Board of Trustee (BOT) Activities during year 2021:

During the financial year 2020-21, even though no formal meeting could take place of BOT, due to pandemic situation, following activities were carried out:

- 1. All investment instruments of BOT and JMP were monitored, regularised and updated.
- 2. It was noted that as per the constitution of the AMPI, Trust Fund should consist of
 - a. All donations received other than specific activities
 - b. Subscription of all life members
 - c. Admission fee of members
 - d. Up to 25% of the net income after each financial year.

As a follow up action, AMPI EC has transferred life membership subscription of new members to AMPI Trust. AMPI EC is requested to take care of other points also as mentioned above.

- 3. It was also noted that Chapters of AMPI are liable to AMPI according to Clause X of the constitution. Financial liabilities are defined in Clause X, 7 and 8. It is recommended that EC of AMPI should discus and clarify the liability of all its Chapters.
- 4. No personal meetings could be conducted due to Corona pandemic.
- 5. Coordination with CA Shri Ramesh Iyer at Mumbai was done with regard to auditing of accounts of BOT and JMP.
- 6. All investments of BOT in the banks were renewed and updated.
- 7. Further investments of BOT are under review.

V) Scientific Journal of the Association

Report of Journal of Medical Physics (JMP) activities for the year 2021.

"All the 4 issues of 2020 of Journal of Medical Physics (JMP) were published in time in spite of the outbreak of Covid-19. During 2020, a total of 129 manuscripts were received and evaluated. Out of these, 38 manuscripts were accepted, 84 were rejected and 6 were withdrawn. The published manuscripts included a Review Article, Original Articles; Editorial, and Scientific / Technical Notes, Letters to Editor and Book Reviews. For the year 2021, the three issues have already been published and the preparation for the 4th issue is under progress. A new manuscript handling website has been developed and introduced by the Publisher. This is being evolved and therefore taking considerable efforts and time of the Editors till the handling becomes seamless. During the current year (till Nov 30, 2021), 203 manuscripts have been received and a decision on several of them has been arrived at whereas several others are under processing. As per the prevalent practice, each manuscript was reviewed by a minimum of 2 referees and the peer reviewing was kept mandatory for all manuscripts (including Editorials) whether invited or proffered.

The submissions of manuscripts has considerably increased not only from India but also from other developed and developing countries. This indicates the continuous increase in the popularity of JMP. The work of handling and refereeing the manuscripts has also increased accordingly. Also, the variety of the manuscripts covering new topics / newer research has also gone up. Obviously, this needs to strengthen and upgrade the Editorial Board and to attract experts from different fields to undertake the refereeing for JMP so as to enhance the quality and the speed of the refereeing process."

(VI) Scientific Conference/Workshop/Symposia of the Association Report of AMPICON2020

The 44th Annual Conference of Association of Medical Physicists of India, AMPICON-2020, was held on 20th March 2020 at BARC, Mumbai. This

conference is being organized by Dr.S.D.Sharma, RPAD, BARC, Mumbai as a hybrid conference (Physical as well as online conference).

The **theme** of the conference was "**Technological Innovations in Medical Physics**". Around two hundred (200) delegates of Medical Physicists, from different parts of the country and abroad and students of this disciplines participated in the conference. The one day hybrid conference featured four scientific talks on:

- 1. Biological bases of the modified fractionation schemes-Dr.B.S.Rao Mumbai.
- 2. Challenges in small field dosimetry-Dr.M.Ravikumar, Bangalore
- 3. Physical and clinical aspects of plaque brachytherapy-Dr.U.Selvaraj, Coimbatore
- 4. Technical Advances in Medical Imaging- Dr.Sameer Tipsnis, USA.

AMPI Awards 2020 during AMPICON2020

(i) Dr. Ramaiah Naidu Memorial oration of 2020 Awardee

Dr.S.P.Mishra received AMPI Dr. Ramaiah Naidu Memorial oration for the year 2020 during AMPICON-2020 through hybrid mode conference and he is presently Emeritus Scientist working in Dr.Ram Manohar Lohia Hospital, Lucknow. He has outstanding contribution to the medical physics community nationally and internationally.

VII. College of Medical Physics of India (CMPI)

College of Medical Physics of India activities for 2021 as follows:

In the first online meeting of elected members on 1st May 2021, Chairman Dr T Ganesh announced the new office bearers and new Board stated the activities as follows:

1. CMPI written exam 2020 results

CMPI had 11 centers for the part one written exam across the country for the year 2020. A total of 45 candidates paid the part one examination fee. Part one exam was conducted on 28 November 2020, for which 32 candidates appeared for the exam (68% attendance). The written exam evaluation was done in ACTREC, Mumbai, on 30 January 2021, and 20 candidates (63% passing) cleared the part one exam.

2. CMPI ORAL EXAM 2020

As mentioned above 20 candidates passed the part one written exam, and we had to postpone CMPI oral exam for the year 2020 twice due to Covid pandemic. Finally, CMPI suggested date for CMPI oral exam on Nov 10th 2021, with AMPICON2021. At the last moment, the organizers postponed the AMPICON because of COVID restriction by the local government. It was decided by the board to, conducted the oral exam on 13th November 2021, at Kidwai Memorial Institute of Oncology Cancer Research, Bengaluru. Sixteen (16) candidates appeared for the exam and 10 candidates have qualified for the oral exam (63% passing). The same list is as below:

Minutes of 44th Annual General Body Meeting of AMPI

The 44th Annual General Body Meeting (AGBM) of the Association of Medical Physicists of India was held through hybrid mode (physical presence plus video conferencing mode) on 20th March, 2021 (Saturday) at 16:30 hrs (4:30PM).

There were 137 members who attended AMPI 44th Annual General Body Meeting. The President (Dr. S. D. Sharma), AMPI chaired the General Body Meeting and he welcomed all AMPI members. President requested Secretary AMPI (Dr. Shobha Jayaprakash) to conduct the proceeding of the meeting with the listed agenda and following are the agenda wise description of discussion and decisions:

1) To read and confirm the minutes of the 43^{rd} Annual General Body meeting held on 8th November 2019 at 5.30 pm at the venue of AMPICON2019 in Kolkata.

Secretary, AMPI, displayed the minutes of 43rd Annual General Body meeting held on 8th November 2019 at the venue of AMPICON 2019 in Kolkata and it was approved unanimously.

Proposed by: Dr. Srinivas Challapalli Seconded by: Dr. K. Muthuvelu

2) To examine and adopt the report of Executive Committee of the Association for the vear 2019-20

The Secretary, AMPI informed the house about the report of the Executive Committee of AMPI for the year 2019 – 2020. Highlights of the report were:

a) To discuss matter related to Medical Physics courses including internship

It was brought to the notice of EC that Medical Physics students are not getting opportunity for undergoing internship and hence they are in problem for completing the course as per AERB requirement. It was also noted that many interns are not getting stipend and they are even required to pay tution fee for undergoing internship. It was further informed to EC that AERB has made it mandatory that course conduction institution shall make arrangements for internship for all their students. This is one of the requirements for approval of course by AERB. EC was also informed that AERB and BARC is conducting periodic review of Medical Physics program which will help in minimizing difficulties faced by students.

b) To discuss about Dr. Ramaiah Naidu Memorial Oration Award 2020

EC members proposed following five names for this award:

Dr. Paul Ravindran, Dr. Thayalan, Dr. B. S. Rao, Dr. S. P. Mishra and Dr. A. K. Shukla. In order to follow the chapter wise rotation policy, EC decided to finalise Dr. S. P. Mishra from Northern Chapter for RNMOA 2020.

c) To discuss about the emergency fund to help a medical physicist during an economical crisis due to huge expense occurred in treatment of certain disease of himself or his family members.

It was decided that AMPI will have a kind of Corpus fund of around 1 lakh for this purpose. The decision on the emergency fund will be taken on a case to case basis. Up to Rs. 50,000/- may be given to a Medical Physicist only (not family members), preferably having AMPI membership, and the age is not exceeding 45 years who is suffering from serious ailment.

d) To discuss about the Allied Healthcare Professions Bill, 2020.

President AMPI briefed EC about the details of the Bill. The pros and cons of the Bill and formation of an independent Council within the Commission were discussed in length. EC was also informed about the AMPI representation to the Honourable Chairman, Parliamentary Standing Committee, Health & Family Welfare in February 2020 and the representations sent to Honourable MPs, Rajya Sabha during 20th and 22nd Sept, 2020, to make a separate category for Medical Physics profession in the National Commission on Allied and Healthcare Professions Bill 2020. It was decided that the committee formed to look into such matters in the past will have the full liberty to do the needful in coordination with AMPI office (President/Secretary).

e) To discuss about reconstituting the AMPI Committee to look into the NCAHP Bill 2020 related issue and follow up.

President AMPI briefed the members about the need to reconstitute the committee and later invited opinions from all members present. After a long discussion it was decided to form AMPI Coordination committee with the following members:

Dr Manoj Semwal (Convenor), Dr V. Subramani (Co-Convenor), Dr Pratik Kumar, Dr. Vinod Pandey, Mr. Suresh Chaudhary, Dr A.K.Rath, Dr Ravi Kumar

In addition to the core committee it was decided to form an Advisory Committee with the following experienced and Senior AMPI members:

Dr Arun Chougule, Dr Paul Ravindran, Dr Radiakrishnan Balan Nair, Dr Raghu Ram Nair, Dr Mariadas, Dr Kaliyappan, Dr Madhusudan Sresty, Dr D.K.Ray and Mr Suresh Pangam

The coordination committee can have group meetings with the Advisory committee and Coordination committee can come to a decision as to how the representation can be submitted. The Co-ordination Committee is fully empowered to take decisions in the matter pertaining to AMPI representation for NCAHP Bill 2020, in collaboration with AMPI office. The Convenor of the Coordination committee reports to the President/Secretary who will in turn communicate to EC as an when required. This was agreed by the members present.

f) To discuss about Correction in Radiological Physics in MCI TEQ 2020.

The draft of our representation was circulated among EC for the correction related to the post of Assistant Professor. Since 3 years of Junior Residency and 1 year of Senior Residency program is not available for Medical Physicists, slight modification was required. It was felt necessary to send

a representation to MCI that 4 years of working experience as Medical Physics professional shall be declared eligible for the post of Assistant Professor. However, Dr. Pratik Kumar was of the opinion that we should hold it for some time because NMC is not very positive of considering request from non-medicals.

g) To discuss about regulation of Medical Physics courses in India

Dr. Challapalli Srinivas briefed EC about the problems related to internship and the minimum requirements for starting Medical Physics course. Dr. S. D. Sharma informed EC that AERB has streamlined the requirements for starting a Medical Physics course and provided the necessary details.

The annual report of the executive committee with the above highlights were accepted and approved by the house.

3) To examine and adopt the reports of Board of Trustees and CMPI for the year 2019-2020

The Secretary, AMPI informed the house about the report of BOT and CMPI for the year 2019-20. It was unanimously adopted by the house.

4) To examine and adopt the Audited Statement of Accounts and Balance Sheet of the Association for the Year 2019-20 and proposed budget for the year 2021-22

5) Progress of AMPICON 2021 and bid for AMPICON 2022

Progress report of AMPICON 2021:

Dr K.M. Ganesh was invited to apprise the progress of AMPICON 2021 to the house. He informed that AMPICON 2021 will be a 3 day conference from 12th to 14th November, 2021. It will be organized at NIMHANS Convention Centre, Bangalore. He also informed that the registration fee

will be same as the previous conference. A pre-conference workshop on 'Advanced Dosimetry' will be organized on 11th November, 2021, by AMPI, in collaboration with ESTRO.

AMPICON 2022 bidding:

Secretary, AMPI informed the house that AMPI office has received two proposals to host AMPICON2022. One is from Mr. Adavala Mallikarjuna supported by TS&AP Chapter of AMPI and the second one was from Dr. V. Subramani (AIIMS, New Delhi) supported by Northern Chapter of AMPI. Both the bidders gave Power point presentations regarding the venue and the facilities available. Voting was conducted to decide the host for AMPICON 2022. The majority approved the proposal for hosting AMPICON 2022 by AIIMS, New Delhi. The host institution of AMPICON 2022 will be asked to submit the undertaking as per the norms of the AMPI.

6) To inform GBM about the AMPI-ESTRO collaboration

Secretary AMPI informed the house that AMPI has signed a collaboration agreement with ESTRO to strengthen the profession of Medical Physics. This collaboration can further be utilised to organise educational events.

7) Approval of amended AMPI Constitution

President AMPI briefed the General Body regarding the items that were modified in the AMPI Constitution. The Election rules which were part of the Constitution have been taken out of the Constitution since it is a changeable item. Similarly Journal related items, Code of Conduct for AMPI/EC members and AMPI awards which were part of the Constitution has been taken out. These changes were proposed as part of the legal suggestion from a legal expert. This is because for any changes made in the Constitution, we need to go back to Charity Commissioner for getting it endorsed.

- (i) President AMPI explained the major changes that were made in Clause VI Administration, point no 1 (i), (ii) & (iii) and the rest were just editorial changes. In sub-clause (i) the major change that was made was that the election of office bearers and members were done directly by members of the association.
- (ii) Secondly in sub-clause (ii) when there is a premature vacancy in the post of office bearer of EC or BoT, Constitution was not very clear, so clarity has been brought about in the proposed draft. In sub clause (iii), one condition has been introduced that only life members of AMPI who have post M. Sc. Diploma in Radiological/Medical Physics or M.Sc. in Medical Physics from a recognized university/ institution are only eligible for the post of office bearers of EC and BOT. Others can be members of EC or BoT.

The nomenclature of Secretary has been changed to **Secretary General** to differentiate from Chapter Secretary. The AMPI Constitution being an important item needs to be discussed in detail and due to shortage of time the General Body decided to keep this agenda on hold and to have further discussion during next General Body Meeting.

The items that were taken out of the constitution would be thoroughly revised by EC and brought to the next General Body meeting for discussion and approval.

8) Declaration of AMPI (EC, BOT and CMPI) Election 2021 – 2024 results and approval by General Body.

The Election officer, Dr. Nirmal Painuly was requested to declare the results of AMPI Election for the term 2021 - 2024 before the General Body. Election officer read out the results of AMPI elections for EC, BoT and CMPI Board along with the names of the newly elected members. There were 15 posts of EC and 5 posts for BoT (4 nominations were received). Thus, All four were declared elected to BoT unopposed. Similarly there were 8 posts for CMPI Board and 8 nominations were received. Hence there was no need to conduct elections for CMPI board members. (Copy of the results of AMPI elections for the term 2021-24 is attached).

For the electing the office bearers of AMPI EC: There were only one nomination each for the posts of Secretary, Joint Secretary and Treasurer and hence no voting was required for these posts.
