



An Overview of Association of Medical Physicists of India

The Association of Medical Physicists of India (AMPI) was established in 1976 as a non-profit public trust organization with the objectives (i) to promote the advancements of physics as applied to medicine especially radiotherapy, nuclear medicine, radiology and biological sciences (ii) to take appropriate steps to carryout, support and to encourage research and development as well as teaching with various fields associated with application of physics in medical sciences (iii) to provide the forum for persons who are engaged or interested in the field of Medical Physics and to arrange scientific meetings and discussion.(iv) to initiate measures to disseminate worldwide information (v) to promote academic status of medical physics work is carried out in India and to encourage appropriate authorities to implement the suggestions laid down by the Association (vii) to initiate action and maintain the standards in the practice of medical physics by certifying members of AMPI by conducting periodical examinations.

The AMPI is affiliated to the International Organization of Medical Physicists (IOMP) and its constituent member of IOMP regional chapter, the Asia-Oceania Federation of Organizations for Medical Physics (AFOMP). The members' comprising of radiation/medical physicists, radiation oncologists, radiologists, biomedical engineers and technologists. The wide spectrum of membership reflects the multi- disciplinary nature of the medical physics profession and the association.

AMPI is periodically organizing the scientific activities in the form of annual conferences/workshop/symposia for improving professionals' standards for practicing Medical Physicists across the country since its inception. It is important to mention that AMPI "Medical Physics Bulletin" was started in 1976 up to 1996, and thereafter it publishes indexed scientific journal namely "Journal of Medical Physics" (JMP') in every quarterly and it has been accepted as a national leading journal and it has its reputation globally.

AMPI also established its academic wing namely College of Medical Physicists of India (CMPI) in the year 2009, to improve the academic standards and also to maintain the standard of professional practices of the Medical Physicists by conducting competency examination for accreditation and certification similar to the Medical Physics colleges of Canada, Europe, USA and Australia.

The General Body of the association is a supreme authority to control all activities and delegates its power conferred by its constitution to carry out the association affairs of professional, scientific, academic, administrative and financial aspects to achieve the objectives. AMPI is managed by the Executive Committee (EC), the Board of Trustees (BOT), editorial board of Journal (JMP) and the board of College (CMPI). ANNUAL REPORTS FOR THE YEAR 2022-2023

I. Membership

Total 119 new members have enrolled during period from Dec 09, 2022 to October 30, 23 and their data have been uploaded on AMPI website. As on 30th October 2023 there are 2946 life members on the role of association. The details of new members list is enclosed in Annexure I.

II. General Body

The 46th Annual General Body meeting (AGBM) which was held on 06th November, 2022 at AMPICON2022 venue JLN Auditorium, AIIMS, New Delhi and the detailed minutes of 46th Annual GBM is enclosed for member's confirmationin Annexure-II.

III. Executive Committee Administration:

The administration of association is managed by executive committee (EC) and Board of Trustees. The administration related to professional developmentactivities, scientific activities, academic/educational activities and financial activities of the association were carried out and reports of the same is presented for the period of 2022-2023.

Highlights of the Executive committee meeting's important decisions/actions taken

Since the last Annual GBM held on 06th November 2022 at AMPION2022 venue JLN,Auditorium, AIIMS, Delhi, the executive committee (EC) met three times (304th 305th and 306th EC meetings), one in-person meeting and two meetings via online to transact the business of the association. The important decisions/action was taken as follows:

The 304th EC meeting decision AERB

The Secretary, AMPI informed to the EC about the letter received from the AERB in response to AMPI representation on the matter related NMC. As AERB letter was not addressed our issues, Secretary, AMPI requested EC opinion for further action. After detailed discussion, it was decided that a fresh communication addressed to the Chairman, AERB only about the NMC pertinent issue will be sent and also requesting for 5 members AMPI delegation meeting with Chairman, AERB immediately. In this regard, EC also formed the AMPI delegation committee comprising of AMPI President Dr.S.D.Sharma, AMPI Secretary, Dr.V.Subramani, Dr.A.K.Rath, Dr.Arun Chouglue and Dr.Manoj Semwal and AMPI will bear the expenses to this purpose.

<u>NMC</u>

Dr.Manoj Semwal who is responsible for the matter related NMC has informed to the EC

that after handed over 2 lakhs to the Senior Lawyer in supreme court, the senior lawyer is making efforts to get favorable response from concerned authority to resolve the matter amicably before filing the case in the court.

NCAHP

The Secretary, AMPI informed to the committee that there are concerns arising from members regarding the NCAHP council registration with the present stats and corrective solution for the same. The committee has discussed the matter in detail and decided that AMPI will follow-up the matter very closely and wait for the favourable outcome on our matter by commission.

3. Status of Change Report for AMPI Trust regularization

The Secretary, AMPI informed to the EC about the good news that AMPI Change report has successfully completed the due process with Charity Commission, Mumbai and now all new EC, BOT are updated. EC has thanked to all members involved in completing the task and especially thanked to Dr.Suresh Sanaye.S BOT, Convenor for taking lots of efforts in visiting multiple time to the Commission Office to this effect.

4. Application for AMPI endorsement and funding for organizing Workshops and Refresher courses

The Secretary, AMPI informed to the EC that AMPI office has received three applications from Karnataka Chapter, IGMS, Patna and CMC Ludhiana for requesting endorsement and funding for organizing the workshop on behalf of AMPI. After detailed deliberations, it has been decided that AMPI will organize four (4) workshops in a year through AMPI chapters one-by one turn and will provide the funding of 1.5 lakhs for organizing 2 days workshop having 50 participants in different topics covering all aspects of Medical Physics. It has also been decided that the request of both proposal is approved by EC for funding 1.5 lakh to each for organizing the workshop. The proposal for the AMPI endorsement also approved by EC for the workshop organizing by CMC, Ludhiana. It has been informed that CMPI also requested for the fund from AMPI for organizing the refresher course. After detailed discussion, it has been decided that CMPI can either organize 3 days Refresher course and AMPI will provide the amount of 3 lakhs or 5 days refresher course or kind of summer school and AMPI will provide the amount of 5 lakhs. The organizer may also bring the monogram on the same subject. However, this can be finalized by CMPI and AMPI officers about the modality of the same. It was also decided that teachers and also participants can be from all AMPI members, not necessary to restrict only to CMPI members.

5. Application for AMPI overseas travel grant.

The Secretary, AMPI informed to the EC that AMPI office has received one application from AMPI member Dr.Mary Joan requesting for AMPI overseas travel grant (OTG) to attend the AOCMP2022 from 10-12, December, 2022 at Taipei, Taiwan. As she is meeting out all the criteria, EC has approved for AMPI overseas travel grant of Rs.25,000/ for the last quarter of the year 2022 to Dr.Mary Joan subject to not to have surplus grant from any other sources for the same conference. Also, it was decided that AMPI OTG awardee name should be published in the AMPI website so that once in a life time opportunity for all members will be ensured by the transparency process.

6. Anomalies in the educational qualification for Medical Physicist in Nuclear Medicine at AIIMS, Rishikesh.

The Secretary, AMPI informed to the EC that AMPI office has received the information

from AMPI member that AIIMS Rishikesh has advertised recently 06th January 2023 post for Medical Physicist recruitment for both Radiotherapy and Nuclear medicine Department having the education qualification of M.Sc in Nuclear Medicine as well which is not in line with AERB requirement. Similarly, there was recent advertisement from RIMS, Imphal for post of Medical Physicist having pay scale of level 6 of 7CPC which is a Group B post which is not deserve for the Medical Physicist as it is an entry level Group-A post in the Govt organization. After detailed discussion, the committee has decided that AMPI will send immediate representation for correcting the anomalies to the Directors of both institutions and also to take these matters to the Union Minister of India for permanent solution for these recurring problems, by the President of AMPI.

7. AMPI Fellowship/Scholarship for advance practical training- (Eligibility criteria, duration of training and amount of fellowship)

The committee has discussed about inducting the AMPI fellowship program to AMPI member for undergoing the practical training in advanced Radiotherapy centres and decided that the same will be inducted after the recommendations of the subcommittee comprised by Dr.Vijayaprabhu, Dr.K.M.Ganesh and Dr.Finlay and after the final approval of the EC for the same.

8. AMPI Dr P S Iyer Oration

The committee has discussed about the status of inducting AMPI Dr.P.S.Iyer Oration and decided that the title of the Oration will be as "AMPI Dr.P.S.Iyer Oration" and as draft guideline is ready with, the same will be circulated to EC members for final review and then to put up in our AMPI website for the members consent. After members consent, without any objections, the same Oration will be started in the forthcoming ICMP2023-AOCMP2023- AMPICON2023 at Mumbai as decided by the recently held AGBM at AMPICON2022 at Delhi.

9. Any other matter with permission of the Chair.

1. Status of ICMP2023-AOCMP2023- AMPICON2023:

Dr.S.D.Sharma President AMPI has updated to the committee that the arrangements to ICMP2023-AOCMP2023-AMPICON2023 is already started and also launched the website and will be updated with more information to the AMPI members in our AMPI website.

2. It has also been decided that we need to start the process of AMPI election for the year 2024-2027. First, we have to appoint the Election Officer in the month of July so that Election will be completed in time and result will be available during forthcoming AMPICON2023 GBM for the approval and subsequently taking over the office from April 2024 onwards by new team.

3. It has also informed by the President AMPI that our AMPI senior member Dr.P.K.Hota has been appointed as the Chairman of Odissa State Council of Allied Health Profession and committee has congratulated to him for the same.

The 305th EC meeting decision

Action taken report on AMPI matters

(i) The Secretary AMPI apprised to the EC that as decided in the last EC meeting, the scientific events (workshops) have been organized by AMPI-Karnataka Chapter, IGMS-Patna and CMC Ludhiana. The CMPI also organized Refresher course at Calcutta.

(ii) As per the last EC decision, there was a meeting between AMPI officers and CMPI officers and decided to have 4 refresher courses in a year and AMPI will fund 1.5 lakhs for each course to a total of 6 lakhs per year.

(iii) The matter of AMPI fellowship program to AMPI members for undergoing training at advanced RT centres in India will be decided once we receive the subcommittee report for the same.

(iv) Regarding AMPI delegation meeting with AERB Chairman, the President, AMPI Dr.S.D.Sharma informed that as AERB is working for Position Paper. Hence our meeting with the AERB Chairman is possible only after the Position paper regarding radiation safety teachers' qualification criteria is ready with.

(v) It is also informed by the President, AMPI Dr.S.D.Sharma that the Lawyer has not taken any action even after 7 months of receiving Rs 2 lakhs for filing the court case against NMC for inclusion of Radiological Physics as one of the teaching profession

Agenda No 3: Nomination of AMPI Dr.RNMO 2023 award and Dr.P.S.Iyer Oration award

The nomination for AMPI Dr. Ramaiah Naidu Memorial Oration (Dr.RNMO) 2023 award has been discussed in detail and it is unanimously decided to confer AMPI Dr.RNMO 2023 award to Dr. Jatinder Palta, USA and AMPI Dr.P.S.Iyer Oration Award 2023 to Dr.K.N.Govindarajan, Coimbatore. These oration lectures will be delivered duringICMP2023/AMPICON2023 at BARC Convention Centre, Mumbai. The President, AMP will communicate this decision of AMPI EC to the awardees keeping ICMP2023/AMPICON2023 organizer in the loop.

Agenda No 4: Appointment of Election Officer (AMPI Elections for the term 2024 - 27)

The Secretary, AMPI informed to the committee that the current tenure of the AMPI EC, BOT and CMPI is up to 31st March 2024. Hence it is necessary to start the process of AMPI elections so that election results are available for ratification during Annual General Body Meeting 2023 (AGBM2023) which will be held at the venue of AMPICON2023 in Mumbai. Accordingly, it is required to appointment the election officer for conducting the election for the term 1st April 2024 to 31st March 2027 of AMPI EC, BOT and CMPI. The matter was discussed in detail and it was unanimously decided that Shri S. P. Aggarwal, Ex-Head, RSD, AERB and Smt. S. Mahalaxmi, Senior Scientific Officer, RSD, AERB will be the Election Officers for conducting AMPI Elections 2024 - 27.

Agenda No 5: Committee to review applications for different awards.

To evaluate the applications of AMPI Young Investigator Award and AMPI Meritorious Medical Physicist Award, three members committee comprising Dr. Pratik Kumar, Dr.

Challapalli Srinivas and Dr. N. Vijayaprabhu has been constituted. Secretary, AMPI will coordinate with this committee to facilitate the process.

Agenda No 6: Renewal of ESTRO-AMPI MOU for professional development activities.

The Secretary, AMPI informed to the committee that current MOU between AMPI and ESTRO is ending on 11th October 2023 and requested EC opinion for further renewal. EC has discussed in detail and decided to renew the MOU with ESTRO. In this regard, the Secretary AMPI Dr.V.Subramani will communicate with ESTRO Physics officials for further renewal.

Agenda No 7: Proposal for the change of medical physics internship program nomenclature.

Secretary, AMPI informed to the executive committee about the proposal received from EC members regarding the change of nomenclature of Medical Physics Internship program. After detailed discussion on this matter, it was decided to propose the change in the name from Internship to Residency. Further, it was also decided to propose this program for a period of two years in place of internship in radiotherapy for one year. For the two (2) years of Residency, the candidate should be trained for 1 year in medical imaging (diagnostic radiology and nuclear medicine) and 1 year in Radiotherapy. It was also decided to request Chairman, AERB to make necessary provision of qualified Medical Physicists (with Degree in Medical Physics) in Radiology and Nuclear Medicine Departments in order to ensure the safety and quality practice using radiation for diagnosis and therapy, as the advanced radiation technologies such as CT, MRI and PET-CT are increasingly being used in the country.

Agenda No 8: Educational qualifications and experience required for the faculty in Medical Physics programs and the faculty-student ratio.

Secretary, AMPI informed to the committee that the proposal from EC member received regarding Educational qualifications and experience required for the faculty in Medical Physics programs and the faculty-student ratio. The committee has discussed this matter and decided to form subcommittee comprising Dr. Henry Finlay, Dr.K. M. Ganesh and Dr. N. Vijayaprabhu to review the current scenario and come out with recommendations on this matter so that AMPI can take further necessary action.

Agenda No 9: Any other matters with permission of the chair.

1. ICMP2023 Progress:

Dr.S.D.Sharma President, AMPI briefed the committee about the progress of ICMP2023/AMPICON2023 and informed that as of today we have received very less number of abstracts and need to be communicated to our members urgently. In this regard, the committee asked Secretary, AMPI to make urgent communication to our members to make more participation in the conference.

2. Chief Guest & Guest of Honor for AMPICON inaugural ceremony:

The Secretary, AMPI informed to the committee that AMPICON is being national annual scientific event, it is better to have eminent leaders in the AMPICON inaugural function in order to make awareness of our profession amongst the public and Chief Guest may be invited by AMPI and Guest of Honor may be invited by conference organizer for the same. After detailed discussion, it has been decided that both Chief Guest and Guest of Honor will be invited by the conference organizer in consultation of AMPI.

3. AMPI Membership directory update

The secretary, AMPI informed the committee that AMPI membership directory need to be updated as it is long pending and also required in view of upcoming AMPI election. The committee has discussed and decided that the Joint Secretary Mr.Suresh Choudhari will be asked to look into this matter in collaboration with AMPI office.

4. Finance and Auditing of AMPI Chapters and conferences.

The Treasurer AMPI informed the Committee that streamlining of the auditing of the AMPI accounts is important in view of strident regulatory guidelines and compliance and hence all the chapters of AMPI and conference organizers are supposed to adhere to the same. It is also informed by the Treasurer AMPI that the AMPICON2015 and AMPICON 2018 organizers still had not settled the conference account and not yet provided the details regarding GST. It has been decided that an online meeting among the Chapters and conference organizers with auditor will be organized soon to make the auditing process simple.

The 306th EC meeting decision

1. NMC TEQ Regulation matters and Action Plan

The Secretary, AMPI informed the EC that as there is no response from NMC against our representation, it is the time to take concrete action plan of AMPI on NMC matters. After Detailed discussion on the matter and EC decided the following action plan:

2.Draft Report of AMPI Working Group policy on Roles and Responsibilities of Medical Physicists of India

The Secretary, AMPI who is the convener for this task shared the outline of the report to EC. After discussion, it has been decided that the same detailed report may be sent to all EC members through email for the review and will finalize thereafter.

3. To update on AMPI working group on Staffing and Career Progression for Medical Physicists of India.

The Secretary, AMPI informed to EC that he received information from Dr.Vijayaprabhu about the status of the report. It has been informed that the draft report will be shared soon to EC for review and finalization.

4. IDMP2023 celebration and financial support to all AMPI State and regional chapters

The Secretary, AMPI informed to EC that in order to encourage for celebrating the IDMP2023, the proposal of financial support Rs.20,000/for all state and regional chapters of AMPI. After detailed discussion, EC decided to approve the proposal financial support as we provide in the past years.

5. Update on ICMP2023 cum AMPICON2023 progress

The President AMPI who is also the organizing the ICMP2023 informed to the EC that the work related ICMP2023 is progressing well. We have received adequate scientific papers and many foreign delegates for invited for the conference. All EC members are requested to register without payment to the ICMP2023.

6. AMPI Newsletter editorial team.

The Secretary, AMPI informed to EC that AMPI office has received request from the EC member Dr.Pratik kumar to expand the editorial team and nominate Dr.R.K.Bisht as member in the AMPI newsletter editorial team. After detailed discussion, EC decided that this matter may be discussed in detailed in the next meeting when Dr.Pratik kumar is present.

7. Any other matters with permission of the chair.

(i) The President AMPI Dr.S.D.Sharma informed to the EC that there is a need to expand the AMPI journal editorial team as he received the request from current Editor-in-Chief Dr.A.S.Pradhan to ease his work due to aging. After detailed discussion, EC has decided that we may request Dr.A.S.Pradhan for being consultant Editor in order to smooth transition of the journal related work for continuous publication and continue the work till next editorial board formed. EC will decide soon about the Editor-in-Chief, Executive Editor-3 and Associate editor-5 after taking consent from concerned members for the same position.

(ii) The President AMPI Dr.S.D.Sharma informed to the EC that AMPI best papers (oral and poster) awards judges need to be selected by EC and he proposed the following names for the same:

After detailed discussion, EC has agreed the proposal and also decided that Dr.Manoj Semwal EC member will coordinate with judges and finalize and submit the result to the AMPI office for the award announcement.

(iii) The President AMPI Dr.S.D.Sharma informed to the EC that there is no much progress regarding our Medical Physics representation in the Interim Commission for Allied Health Professions (ICAHP) in the Health Ministry. However we are continuously monitoring the meeting outcome of ICAHP and update the same to EC.

(IV) Board of Trustee (BOT)

Report of Board of Trustee (BOT) Activities during year 2022:

During the financial year 2022-23, following activities were carried out:

- 1. The Change Report submission process was initiated in June-2022. After submitting consent from incoming and notarized NOCs from outgoing BOT & EC members, the Change Report was finally accepted on 20th January 2023 by Charity Commissioner's Office.
- 2. First physical meeting of BOT members was held on 6th November 2022 at AMPICON-2022 venue, AIIMS, New Delhi and various issues were discussed.
- 3. All investment instruments of BOT and JMP were monitored, regularised and updated.
- 4. Coordination with CA Shri Ramesh Iyer at Mumbai was done with regard to auditing of accounts of BOT and JMP.
- 5. It was noted that Chapters of AMPI are liable to AMPI according to Clause X of the constitution. Financial liabilities are defined in Clause X, 7 and 8. It is recommended that EC should discus and clarify the liability of all its Chapters to them.

V) Scientific Journal of the Association

Report of Journal of Medical Physics (JMP) activities for the year 2022.

The following text may be considered as annual report on behalf of JMP.

"We feel proud that the Journal of Medical Physics (JMP) has been positively evaluated in the SJIF Journal Rank List evaluation process, which resulted in a good score. Finally an Impact Factor of 0.9 has been allocated in the 2022 Journal Citation Reports (Clarivate Analytics, 2023). This may be considered as an important landmark in the progress of JMP, more so because to achieve SCI indexing with a respectable impact factor was set to be one of the goals while making JMP an online publication in 2006. The allocation of Impact factor has resulted in a sudden surge in the manuscript submission rate and also expected in the positive attitude of the experts for undertaking the refereeing. During 2022, all the 4 issues of JMP were published as scheduled. A total of 119 manuscripts were received and evaluated during 2022. Out of these, 49 manuscripts were accepted, 63 were rejected and 7 were processed in 2023. For the year 2023, the three issues have already been published and the preparation for the 4th issue is under progress. During the current year (till Oct, 2023), 146 manuscripts have been received and a decision on 102 of them has been arrived at whereas others are under processing. The published manuscripts included a Review Article, Original Articles; Guest Editorial, Technical Notes, Letters to Editor, Book Reviews and Conference reports.

The new manuscript handling website developed and introduced by the Publisher has undergone a continuous up gradation based on the feedback from the Editors. The site has now become seamless in operation. To recognise the contribution of the reviewers, an online process of issuing reviewers' certificates has been introduced on the journal site. The desirous referees could now download and print the certificate as per their convenience and need. The double blinded review process of the manuscript has been continued and strictly followed. Each manuscript was reviewed by a minimum of 2 referees and the peer reviewing was kept mandatory for all manuscripts whether invited or proffered contributions Action on upgrading and making major changes in the Editorial Board has been initiated to bring newer faces / experts from different fields so as to take the journal to newer heights.

(VI) Scientific Conference/Workshop/Symposia of the Association Report of AMPICON2022

The 43rd annual conference of Association of Medical Physicists of India, "AMPICON2022", was held from November 5 to 7, 2022 at JLN Auditorium, AIIMS, New Delhi. The theme of the conference was "Medical Physics Research and Practice in the era of Precision Medicine"

Around eight hundred (800) delegates including Medical Physicists, Radiation Oncologists, Radiologists, Radiotherapy Technologists and Engineers from different parts of the country and abroad and students of these disciplines participated in the conference. The conference was inaugurated by Chief of Dr.B.R.Ambedkar Institute Rotary Cancer Hospital of AIIMS, New Delhi and also released the Souvenir of the conference. Dr.S.D.Sharma, the President of AMPI, Chairman of AMPICON2022, Secretary, AMPI and Organizing Secretary of AMPICON2022 were on the dais during the inguration. Many international professional organizations representatives such as John Damilakis (President, IOMP (virtual), Prof. Jitender Palta (AAPM, USA), Prof.Robert Jeraj (AAPM, USA), Prof.SM Krishnan (IUPSEM) and other well-known personalities presented papers in the conference.

The three day conference featured scientific sessions in two parallel tracks discussing the latest scientific research and developments of Medical Physics aspects in Medical Imaging, Radiation Therapy, Nuclear Medicine, Health Physics, Radiology, Quantitative imaging, Particle therapy etc.. Scientists from Atomic Energy Regulatory Board, Bhabha Atomic Research Centre and others from leading Cancer Institute's like across the country participated in the conference.

The conference also encouraged the younger upcoming Medical Physicists in the field by instituting the best oral paper and best poster award. A quiz programme was also conducted for the students to create awareness on recent trends in Medical Physics winner received the AMPI cash award. An e-poster session was also a part of the conference.

On second day, having important scientific deliberations, in the evening, the annual General Body meeting of AMPI was held on 06th November, 2022. The meeting was attended by 94 AMPI members.

On third day, special symposium IDMP2022 AMPI awards ceremony was held and the conference ended on 22nd Nov with the announcement of holding the AMPICON 2016 at Hyderabad.

(i) ICMP2023 Progress Report:

Dr.Sridhar Sahoo, Organizing Committee of ICMP2023 has informed to the house that conference will be held at DAE Convention center, from 06-09 December 2023. The first announcement of brochure of ICMP2023, with all details including delegation fees etc. is shared to house and members present in the house were satisfied on the progress.

(ii) AMPICON2024 Bid

AMPI secretary received the expression of interest for hosting AMPICON2024 in the given format from Dr.Mathusudanan Sresty through his employer and AP-Telengana chapter from Hyderabad. The same EoI has been discussed and endorsed by AMPI EC. As there was only one proposal, the same proposal was approved by the house unanimously.

5. To update on outcome of and the action plan on issues of NMC &NCAHP

The Secretary, AMPI informed to the house that AMPI has further represented the matter of NMC TEQ2022 regulation pertaining to Radiological Physics to the Prime Minister of India through the CPGRAMS portal of Department of Administrative Reforms and Public Grievances on 06th August, 2022. The response to our grievances has been addressed through NMC, PGMEB, Deputy Secretary, Mr. Aujender Singh through the same CPGRMS portal and his response is as Re:

"Dear Sir, The issue of Radiological Physics/Medical Physics which has been left in the TEQ Regulation 2022 is under active consideration and will be sorted out shortly at the time of amendments in the regulation. Please feel free to write back in case on any issue. Thanks & Regards Aujender Singh Secretary, PGMEB email: Aujender.singh@nic.in"

After detailed discussion, it has been decided that we should pursue both administrative avenue by doing follow-up with NMC and also to explore the legal avenue for filing a case against NMC for deliberately delaying the amendments and not including the our speciality professionals in the TEQ regulation 2022.

Similarly, after our representation to the National Commission for Allied and Healthcare Professions (NCAHP) to make amendments in the serial No.8 of the schedule of the NCAHP, Act 2021, we have not got any positive response from NCAHP as of today. After detailed discussion, it has been decided that we should make continuously follow-up for the necessary amendments at the earliest.

6. Any other matters with the permission of the Chairs

- 1. It has been decided that AMPI should sent the letter to Chairman, AERB regarding the qualification for teachers to teach radiation safety subject and also asking for the delegation meeting with Chairman, AERB.
- 2. It has been decided that AMPI should follow up the matter with UGC for recognition of Radiological and Medical Physics subject and request for mandatory requirement for Radiological and Medical Physics faculty for starting academic program in Radiological/Medical Physics across the country.

The meeting was ended with thanks to the chair.


