Candidate with Basic Degree in Science with Physics as one of the subject from recognized University/Institution shall be eligible only for Quality Assurance of Diagnostic X-ray Equipment as a "Service Provider" and he/she are not eligible for servicing and maintenance of x-ray equipment.
